## ALL DEPARTMENTS EXCEPT PRINT MUSIC

### RETURNS WITH AN ORIGINAL SALES RECEIPT WITHIN 30 DAYS OF PURCHASE:

- Any purchase made by cash under \$50.00 will be refunded in cash.\*
- Any purchase made by a check that has cleared the 15-business day waiting period will be refunded in cash.\*
- Any purchase made by a check that has not cleared the 15-business day waiting period may be refunded as a store credit.
- Any purchase made by credit card will be refunded to the original credit card.
- Any purchase made by store credit or gift certificate will be refunded as store credit.

\*Dietze Music will issue a check for refunds over \$50 (checks are issued from Dietze Music Corporate Office in Lincoln, NE).
